#### B. Call to the Public - Mayor

A.R.S. 38-431.01 states the Public Body may make an open call to the public during a public meeting, subject to reasonable time, place and manner restrictions, to allow individuals to address the public body on any issue within the jurisdiction of the Public Body. At the conclusion of an open call to the public, individual members of the Public Body may respond to criticism made by those who have addressed the Public Body, may ask staff to review a matter or may ask that a matter be put on a future agenda. However, members of the Public Body shall not discuss or take legal action on matters raised during an open call to the public unless the matters are properly noticed for discussion and legal action.

#### C. New Business Before Council - Mayor

Public comment will be taken at the beginning of each agenda item, after the subject has been announced by the Mayor and explained by staff. Any citizen, who wishes, may speak one time for five minutes on each agenda item before or after Council discussion. ### **RESOLUTION NO. 2021-19**

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE TOWN OF HUACHUCA CITY, ARIZONA, AUTHORIZING THE TOWN TO EXTEND THE INTERGOVERNMENTAL AGREEMENT WITH THE WHETSTONE FIRE DISTRICT FOR FIRE AND EMERGENCY MEDICAL SERVICES.

WHEREAS, Huachuca City ["Town"] and Whetstone Fire District ["District"] entered into an agreement ["Agreement"], pursuant to which, District provides fire suppression, fire prevention, code review and inspection services, emergency medical services, emergency hazardous substances response services, and other services incidental to the protection of persons and property within the Town; and

WHEREAS, the second extension of the Agreement is due to expire; and

WHEREAS, Town and District, through their respective Town Council and Fire District Governing Board, have determined that it is in the best interest of the public that each entity extend the Agreement to continue to provide fire suppression and EMS services in the Town; and

WHEREAS, the Town and the District have developed a third extension to the Agreement by which the District will continue to provide fire and emergency medical services to the Town, which extension is attached hereto as Exhibit AA@ and incorporated herein by this reference; and

WHEREAS, the Mayor and Council have determined that approval of the third extension of the Agreement is in the best interest of the Town and its residents.

**NOW, THEREFORE**, **BE IT RESOLVED** by the Mayor and Council of the Town of Huachuca City, Arizona, as follows:

- **Section 1.** The Town hereby approves the third extension of the Agreement, attached hereto as Exhibit AA.@
- Section 2. The Town's officers are hereby authorized and directed to execute said third extension to the Agreement on behalf of the Town of Huachuca City.
- **Section 3.** The Town's officers and staff are hereby authorized to take all steps necessary and proper to continue operating under the Agreement and give it effect.

# INTERGOVERNMENTAL AGREEMENT TO PROVIDE FIRE PROTECTION

**THIS THIRD EXTENSION** ("Extension") OF THE INTERGOVERNMENTAL AGREEMENT FOR FIRE PROTECTION SERVICES ("Agreement") is made and entered into effective December 1, 2021, by and between the TOWN OF HUACHUCA CITY and the WHETSTONE FIRE DISTRICT.

#### **RECITALS**

**WHEREAS**, Huachuca City ["Town"] and Whetstone Fire District ["District"] entered into an agreement ["Agreement"], pursuant to which, District provides fire suppression, fire prevention, code review and inspection services, emergency medical services, emergency hazardous substances response services, and other services incidental to the protection of persons and property within the Town; and

WHEREAS, the second extension of the Agreement is due to expire; and

**WHEREAS**, Town and District, through their respective Town Council and Fire District Governing Board, have determined that it is in the best interest of the public that each entity extend the Agreement for three months to continue to provide fire suppression and EMS services in the Town.

**NOW, THEREFORE**, **Town and District agree** to amend section 2(A) of the Agreement, as follows, with deletions in strikeout text and additions in underlined text:

#### 2. **TERM & TERMINATION**:

A. Term: This Agreement shall commence on the 1<sub>st</sub> day of November, 2017 (the "**Effective Date**"), and continue thereafter until December March 31, 20212022, unless earlier terminated as provided herein. The term of the Lease of the Fire Station Facilities, as provided in paragraph 10 below, shall be coterminous with the term of the Agreement. These two terms shall be jointly referred to in this Agreement as the "**Term**".

**Town and District further agree** that the rate of compensation for the additional three-month period shall be the same as the rate currently paid by Town to District.

**Town and District further agree** that all other terms of the Agreement, not expressly amended by the Extension, shall remain in full force and effect.
