B. Call to the Public - Mayor

A.R.S. 38-431.01 states the Public Body may make an open call to the public during a public meeting, subject to reasonable time, place and manner restrictions, to allow individuals to address the public body on any issue within the jurisdiction of the Public Body. At the conclusion of an open call to the public, individual members of the Public Body may respond to criticism made by those who have addressed the Public Body, may ask staff to review a matter or may ask that a matter be put on a future agenda. However, members of the Public Body shall not discuss or take legal action on matters raised during an open call to the public unless the matters are properly noticed for discussion and legal action.

C. New Business Before Council - Mayor

Public comment will be taken at the beginning of each agenda item, after the subject has been announced by the Mayor and explained by staff. Any citizen, who wishes, may speak one time for five minutes on each agenda item before or after Council discussion. Questions from Council Members, however, may be directed to staff or a member of the public through the Mayor at any time.

RESOLUTION No. 2024-12

A RESOLUTION OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF HUACHUCA CITY, COCHISE COUNTY, ARIZONA, CANVASSING THE RESULTS OF THE GENERAL ELECTION HELD ON NOVEMBER 5, 2024.

WHEREAS, the Town of Huachuca City, Cochise County, Arizona, held a General Election on the 5th day of November, 2024, for a popular vote on: a proposition for extension of the Alternative Expenditure Limitation "Home Rule Option," and three councilmember seats; and

WHEREAS, the election returns have been presented to and have been canvassed by the Town Council.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Town of Huachuca City, as follows:

SECTION 1. That the votes cast for Proposition 424, extension of the Home Rule Option, were as follows:

SECTION 2. That it is hereby found, determined and declared of record, that Proposition 424, extension of the Home Rule Option, has been approved by the voters, and the Town Clerk is directed to notify the Auditor General and Economic Estimates Commission of the result, forthwith.

SECTION 3. That the votes cast for the candidates for the three councilmember seats, were as follows:

SECTION 4. That it is hereby found, determined and declared of record, that the following three candidates did receive the greatest number of votes of the electors of the Town voting on the three councilmember seats:

Danielle Cardella Christy Hirshberg Nallely Arreola

SECTION 5. Pursuant to the Town Code, section 2.15.015 (C), the three successful candidates [Danielle Cardella, Christy Hirshberg, and Nallely Arreola] shall be declared elected to the office of Councilmember of the Town of Huachuca City, effective immediately; and the Town Clerk is hereby directed to issue to them Certificates of Election for their respective terms of office.

SECTION 9. This Resolution shall be in full force and effect immediately upon its adoption.
