Mayor Wallace presents an award to Frank and Nancy of 408 Third Street in Upper Huachuca City. Neither one of them could make it tonight.

Mayor Wallace presents an award to Thomas and Brooke of 126 Navajo Street in Lower Huachuca City. Brooke is present to accept the award.

E.2 Discussion and/or Action [Mayor Wallace]: RESOLUTION NO. 2025-02 - A RESOLUTION OF THE MAYOR AND COUNCIL, APPROVING AND ADOPTING A MINOR GENERAL PLAN LAND USE AMENDMENT TO CHANGE THE LAND USE FROM "COMMERCIAL" TO "MULTI-FAMILY RESIDENTIAL" FOR AN APPROXIMATELY 2.64-ACRE SITE, LOCATED AT 712 N. GONZALES BLVD., OTHERWISE KNOWN AS COCHISE COUNTY PARCEL NO. 10647024, TO BRING THE PROPERTY'S EXISTING AND LAWFUL USE INTO CONFORMANCE WITH THE TOWN'S LAND USE MAP, AS DESCRIBED IN CASE NO. GP2024-01.

Motion: Item E.2 Action: Open for Discussion and/or Action, moved by Johann Wallace, Seconded by Cynthia Butterworth.

Mayor Wallace advised that there was just a Special Meeting regarding this amendment.

Motion: <u>RESOLUTION NO. 2025-02</u> Action: Approve, moved by Johann Wallace, Seconded by Cynthia Butterworth.

Motion passed unanimously.

E.1 Discussion and/or Action [Mayor Wallace]: Interviews of applicants to fill the vacant Council seat. Following the interviews, the Council might vote to appoint an applicant to fill the vacancy on the Town Council.

Motion: Item E.1 Action: Open for Discussion and/or Action, moved by Johann Wallace, Seconded by Cynthia Butterworth.

Council interviews Joseph Ludi who was a late applicant to fill the vacant seat. If chosen, he would not be able to take his seat tonight.

Council interviews Geovona Thompson. She would be able to be sworn in and take her seat tonight.

Motion: Geovona Thompson to fill the vacant Council Seat Action: Appoint, moved by Johann Wallace, Seconded by Cynthia Butterworth.

Motion passed unanimously.

Mayor Wallace swears in Geovona Thompson and she takes her seat.

E.5 Discussion and/or Action [Suzanne Harvey]: Overview by Paul Juhl, of Tierra Water Management, of the state and federal lead pipe inventory requirements for the Town's water system.

Motion: Item E.5 Action: Open for Discussion and/or Action, moved by Johann Wallace, Seconded by Cynthia Butterworth.

Paul Juhl discusses the lead pipe inventory and the process and requirements for completing them. He clarifies that this requirement does not mean that there are lead pipes, it means that we have to check. No lead has been found in the water samples in any year since we were required to test.

E.6 Discussion and/or Action [Suzanne Harvey]: Approval to begin planning a retreat for Council and Department Heads to work on the Town's Strategic Plan.

Motion: Item E.6 Action: Open for Discussion and/or Action, moved by Johann Wallace, Seconded by Cynthia Butterworth.

Manager Harvey explains that most cities and towns do this on an annual basis or at least a biannual basis. She states that in talking about this with Ruben, Mr. Benavidez and Department Heads, it is thought that this would be a good idea for Council and Staff to get together and discuss what the long term vision is and how we get there. We need to start planning further out, especially when it comes to the budget.

Councilmembers Trate, Thompson and Butterworth express concerns about the follow through and how beneficial it would be.

Councilmember Cardella thinks it would help with teambuilding and helping make better more informed decisions as a Councilmember.

Mayor Wallace has concerns that Department Heads won't speak as openly if Council is also present. He would like staff to work on this and present it to Council.

Manager Harvey wants Council input so that Staff isn't working on things and spending time on projects/plans that Council doesn't want done.

Manager Harvey also believes that Council needs to be able to openly speak between each other and staff and this is an opportunity for that.

Mayor Wallace also has concerns about Open Meeting Law.

Mr. Benavidez advises that cities and towns do this all the time and he will make sure that we stay within the law.

Motion: Go forward with scheduling the retreat to work on the Town's Strategic Plan Action: Direct Staff, moved by Johann Wallace, Seconded by Cynthia Butterworth. Motion passed unanimously.

E.7 Discussion and/or Action [Stephanie Fulton]: Approval of a Memorandum of Understanding Between United Way of Tucson and Southern Arizona and Huachuca City Library for Volunteer Income Tax Assistance (VITA) hosting at the library.

Motion: Item E.7 Action: Open for Discussion and/or Action, moved by Johann Wallace, Seconded by Cynthia Butterworth.

Mayor Wallace confirms that this is the same free service as in prior years.

Motion: A Memorandum of Understanding Between United Way of Tucson and Southern Arizona and Huachuca City Library for Volunteer Income Tax Assistance (VITA) hosting at the library. Action: Approve, moved by Johann Wallace, Seconded by Cynthia Butterworth. Motion passed unanimously.

E.8 Discussion and/or Action [Suzanne Harvey]: Approval to rent a Scraper Tractor for landfill operations.

Motion: Item E.8 Action: Open for Discussion and/or Action, moved by Johann Wallace, Seconded by Cynthia Butterworth.

Concerns are addressed as far as why our Scraper is down again and we have to spend money on a rental again. Manager Harvey advises that if our scraper gets fixed, we will return the rental prior to the one month she is asking for currently.

Motion: the rental of a Scraper Tractor for landfill operations for 1 month Action: Approve, moved by Johann Wallace, Seconded by Cynthia Butterworth.

Motion passed unanimously.

E.9 Discussion and/or Action [Suzanne Harvey]: Approval of repairs to the Town's Caterpillar 613 Scraper Tractor.

Motion: Item E.9 Action: Open for Discussion and/or Action, moved by Johann Wallace, Seconded by Cynthia Butterworth.

Council expresses their displeasure at the fact that the scraper is down again. This failure is due to negligence/neglect. Manager Harvey advises that disciplinary action is being taken. Mayor Wallace wants the problem fixed, he doesn't care how.

Motion: repairs to the Town's Caterpillar 613 Scraper Tractor in an amount not to exceed \$35,000.00 Action: Approve, moved by Johann Wallace, Seconded by Cynthia Butterworth. Motion passed unanimously.

E.10 Discussion and/or Action [Mayor Wallace]: <u>RESOLUTION NO. 2025-01 -</u> A RESOLUTION OF THE MAYOR AND COUNCIL, IDENTIFYING THOSE OFFICERS LEGALLY EMPOWERED TO PROVIDE INSTRUCTIONS AND SIGN DOCUMENTS ON BEHALF OF THE TOWN RELATING TO THE TOWN'S ACCOUNTS WITH US BANK NATIONAL ASSOCIATION.

Mayor Wallace explains that this is because no one currently with the Town has access to this account and we need to get it fixed.

Motion passed unanimously.

Dec. 19th attended the dinner for the state transportation board, then on the 20th went to the board meeting. Food distribution and the Holiday Gift basket event were also on the 20th. On January 29th there is another MPO meeting. Still don't have an alternate so if anyone would like to do that, you would not be a voting member. Mayor Wallace- Projects at Hunt park finally getting worked on. ADOT started on the highway out by the checkpoint. Hispanic Chamber mixer tomorrow evening. Saturday is the New Year Reception with the NetCom CG. Mayor Manager Meeting at Gunny's Barbecue at the end of January.
