- E. Reports by Council Members and Officers

- 1. *Councilmember Welsch Library/Senior Center-*. Councilmember Welsch stated the Library has finished up with their reading program. Also there were not a lot of supplies but she made it happen. Councilmember Perry stated he has a list of those major contributors of school supplies and would like a plaque of appreciation made for them when the clerk gets back.
- 2. *Councilmember Gonzales– Planning and Zoning-*. Councilmember Gonzales said they did not have a quorum for the last meeting and were not able to work on any agenda items. Councilmember Gonzales said there are questions on the (composed granite). Is the sidewalk that ADOT is putting in, is this kind of composed granite? Dr. Johnson stated most of this is mostly concrete and he is not sure where they are doing the composed granite.
- 3. *Councilmember Wallace Parks and Recreation-*.Councilmember Wallace stated they have a large event the (Home Based Expo) coming up on September 19, 2015. There is also an opening on the Parks & Rec's Board.
- 4. *Councilmember Johnson Public Safety*-Councilmember Johnson stated she spoke with Asst Chief Theis and he is in the upper 3% of his class. The Fire Department's EMTs have very busy lately.
- 5. *Mayor Pro Tem Perry Public Works-* Mayor Pro Tem Perry stated that SSVEC is putting electric meters on our Wells that have been having low pressure problems. This is an electric problem and they are helping us to get this fixed. Councilmember Perry said we had an individual that put a lot of stuff in the alley and we cleaned it up and sent her a bill. Also, if any citizen would like to rent our dump truck you can for \$25.00 a day. That is much cheaper than us cleaning it and sending you a bill. Councilmember Perry said we finally got the scale at the Land fill replaced and completed. The Landfill is still staying on the dust, and soon we will have a sprinkler on the scrapper.
- 6. *Councilmember Hirshberg– Finance-*.Councilmember Hirshberg said things are going as usual.
- 7. *Mayor Taylor*-Mayor Taylor stated that with the investments, we have just finished all the signing of paperwork and no funds have been moved this time. Mayor Taylor said with the Wells they are blowing fuses ad having intermitting power surges. SSVEC is being very helpful in getting this problem fixed. Mayor Taylor stated that ADEQ has received complaints and came to us and said we need to have an air quality permit. This has been monitored for years and we received notice that we are not in violation, do not need any permit and our Land fill is not large enough for those types of permits. If someone has questions please come and talk to the Mayor or the city clerk because all these things cost us money. Mayor mentioned that with the sidewalk project we do not know exactly where it starts or ends. They will be putting in park benches and trashcans. The monuments are being erected and will be finished soon.
