HUACHUCA CITY TOWN COUNCIL MINUTES REGULAR MEETING AT 7:00 PM THURSDAY, APRIL 13, 2017

- A. The Meeting was Called to Order at 7:00 p.m. and the Pledge of Allegiance was said.

C. Approval of Regular Minutes from the Town Council Meeting of March 23, 2017 and Workshop from January 17, 2017. Motion made by Mayor Taylor to approve the Regular Minutes March 23, 2017 as corrected and Workshop Minutes from January 17, 2017, seconded by Mayor Pro Tem Johnson. Council Member Hirshberg abstained do to being absent at the last meeting.

D. Call to the Public [3 minute limit] Agenda Items Only. (See below) Mr. Josephson commented that we need to have copies of Resolutions or Ordinances for the public to read prior to the meeting.

E. Reports by Council Members and Officers:

- 1. Council Member Welsch Library/Senior Center-Council Member Wallace stated that the new rotor has been installed and it seems to be working. Clerk Mitchell commented that the Norma Lavender Garden Opening will be on April 22, 2017.
- 2. Council Member Johann-Wallace-Planning and Zoning- Council Member Wallace reported that the P&Z had their meeting on April 8, 2017 we had WLB and comments are due by April 17 then they will get started sending the draft out. He will put the dates on the Web Site. The P&Z is also working on the Sign Code with Dr. Johnson.
- 3. Council Member Butterworth -Public Safety -Council Member Butterworth reported that as of 04/08/2017 the Police responded to 903 calls for service, 461 traffic stops, issued 162 warning and equipment repair order with 221 separate violations, issued 289 separate charges on 208 tickets and processed 40 arrests. The Animal Control responded to 48 calls for service. The Fire Department responded to 129 EMT calls and 24 fire calls. Dispatch cleared 110 calls, answered 3,185 calls and greeted 1,170 visitors. Chief Allmon said things are going well he just received pictures from our new fire truck looking at delivery in May. Chief Allmon stated there was a fire on Ft. Huachuca's East Range that is currently maintained. Chief Thies read a Proclamation for the Animal Control employees for Animal Control Week.
- 4. Council Member Hirshberg-Parks and Recreation- Council Member Hirshberg reported that they have been selling Circus Tickets at Ace Hardware and she would like to thank them for letting her set up there. Also, the Chili Cook-off and the Bicycle Rodeo will be postponed until we find a better time. The City Wide Yard Sale will be on May 20, 2017.
- 5. Mayor Pro Tem Johnson Public Works (PW) Mayor Pro Tem Johnson said that PW is doing a great job cutting the grass and cleaning the alleys. Chief Allmon stated that the Land Fill is doing better and moving forward. We are still looking at hiring another person.
- 6. Mayor Mayor Taylor-Mayor Taylor said we will start scheduling budget workshop soon and we are having a Planning Workshop on May 2, 2017.
- 7. Town Clerk/Administrator Report- Clerk Mitchell reported that she has been working with Ms. Williams with (SEAGO) on the CDBG Grant and preparing for the bid packets. The packets will first be sent to the state (ADOH) then back to us when approved.
