- E. Reports by Council Members and Officers:
 - 1. Council Member Welsch Library/Senior Center-Clerk Mitchell gave Ms. Harvey Library report to the council; since last report we have been gearing up for the Summer Reading Program called "Build a Better World" this starts on June 6, 2017. The Summer Splash registration has begun; the Sierra Vista Garden Club made a field trip to our beautiful Norma Lavender Discovery

- Garden on May 25th and for our monthly display for our foyer is Asian/Pacific Islander.
- 2. Council Member Hjeldness-Finance- Council Member Hjeldness stated we are just working on the budget.
- 3. Council Member Johann-Wallace-Planning and Zoning-Council Member Wallace reported that WLB Group is here and we had a Public Hearing for the Development Plan. This is on the agenda for approval tonight. The P&Z next meeting will be on June 7th they will be working on the sign code. Doc Johnson reported that he attended a FEMA meeting and met with the Head Engineer for FEMA. They talked in length about lower Huachuca City flood area. Doc Johnson was told that we are in the top 10 of projects for them this year so hopefully we can get something done. Doc Johnson conveyed that we are having Gila and School Drive surveyed. The Child Center is moving forward they have received CDBG Funds from the County to restore and remodel this building.
- 4. Council Member Butterworth —Public Safety —Council Member Butterworth reported that as of 05/25/2017 the Police responded to 1,378 calls for service, 787 traffic stops, issued 257 warning and equipment repair order with 342 separate violations, issued 445 separate charges on 346 tickets and processed 50 arrests. The Animal Control responded to 71 calls for service and issued 3 citations citing 5 offenses. The Fire Department responded to 187 EMT calls and 39 fire calls. Dispatch cleared 159 calls, answered 4,743 calls and greeted 1,746 visitors. Fireman Jeff commented that everything is still on track for the new fire truck Chief Allmon is there now checking it out. He also gave the council information on the used truck Chief Allmon is looking at.
- 5. Council Member Hirshberg-Parks and Recreation- Council Member Hirshberg reported that the Parks and Rec's had their next meeting on June 12th We are working on the 4th of July event and have more information coming. There will be an Ice Cream Social in August and the Small Business Expo will be held in October.
- 6. Mayor Pro Tem Johnson Public Works (PW)- Mayor Pro Tem reported that the Land Fill is looking better as we go along. Public Works is cutting grass around town and it is looking a lot better.
- 7. Mayor Mayor Taylor-No report at this time.
- 8. Town Clerk/Administrator Report- Clerk Mitchell reported that the CDBG Grant Process has moved forward and out to Bid. June ^{8th}, 2017 at 3:00 pm. we will open the Bids and have them on June ^{8th} agenda to approve.
