A.R.S. 38-431.01 states the Public Body may make an open call to the public during a public meeting, subject to reasonable time, place and manner restrictions, to allow individuals to address the public body on any issue within the jurisdiction of the Public Body. At the conclusion of an open call to the public, individual members of the Public Body may respond to criticism made by those who have addressed the Public Body, may ask staff to review a matter or may ask that a matter be put on a future agenda. However, members of the Public Body shall not discuss or take legal action on matters raised during an open call to the public unless the matters are properly noticed for discussion and legal action. Mayor Taylor advised the public of some of the accomplishments of Mr. Williams in his short time with the Town, to include being named President of the SEAGO Administrative Council, establishing relationships with the other cities in Cochise County, reducing deficit spending by 75%, changing diesel providers and saving \$13,000 annually, reducing maintenance costs by 94%, naming Suzanne Harvey as the town's PIO and starting the town's Facebook page, purchasing a camera system for the town facilities, increasing animal shelter fees, working with Chief Bidon on fire inspections, getting the landfill equipped properly, working on fees for utilities and working closely with Dr. Johnson on Code Enforcement.
