A.R.S. 38-431.01 states the Public Body may make an open call to the public during a public meeting, subject to reasonable time, place and manner restrictions, to allow individuals to address the public body on any issue within the jurisdiction of the Public Body. At the conclusion of an open call to the public, individual members of the Public Body may respond to criticism made by those who have addressed the Public Body, may ask staff to review a matter or may ask that a matter be put on a future agenda. However, members of the Public

Body shall not discuss or take legal action on matters raised during an open call to the public unless the matters are properly noticed for discussion and legal action.

Spencer Forsberg gives a recap of February's financials, including a few issues that are being worked on and corrected. Some of these were already corrected partway through the month. The most important one is the animal control fees, which show a large profit. Those amounts should actually be credited to the landfill, as they were landfill account payments that were coded to the wrong account. Water sales were low this month as well, we are looking into that. General Fund revenue is at about \$130,000.00 and expenses of \$116,000.00. Year to date performance is close to projected in the budget. Water revenue shows a loss of \$14,000.00 but that is one of the ones mentioned that we are looking into. Sewer shows revenue of \$22,000 and expenses of \$5000.00 so in the black \$17,000.00 for the month. Garbage fund revenue of \$12,499.00 and after contractor and admin fees we zeroed out. Landfill revenue of \$106,460 and expenses of \$98,271.

These were a result of cooperation with TAC to get these things mapped and combined.
