



PSPRS Information

- 1. When are Police Officers enrolled? TBD by Local Board.**
- 2. Tiers:**
 - a. Tier 1, hired into PSPRS Position before January 1, 2012. Defined Benefit (Pension):**
 - i. Chief Thies**
 - ii. Lt. Glowacki**
 - iii. Officer Thompson**
 - iv. Officer Olivas**
 - b. Tier 2, hired into PSPRS Position on/after January 1, 2012. Defined Benefit (Pension):**
 - i. Cpl Arnett**
 - c. Tier 3, hired into PSPRS Position on/after July 1, 2017. Defined Benefit (Pension) or Defined Contribution (401(a) individual must choose plan within 90 days of enrollment into PSPRS using the Members Only website, otherwise will be entered in Defined Benefit Plan. Once a plan is chosen it can not be changed during the person's career.:**
 - i. Cadet Bear (pending decision of local board)**
 - d. NOTE: For Tier 2 and 3, PSPRS offers a Hybrid Plan for agencies with non-social security positions. Does not apply to Huachuca City.**
- 3. Defined Benefit Plans provide for a pension based on salary and years employed in PSPRS system.**

- a. Tier 1: Retirement after 20 years service or age 62 with 15, or more, years. . Reduced for each year under 20 years service. Disability retirement reduced for each year under 20 years service.
 - b. Tier 2: Retirement after 25 years service and age 52.5, age 52.5 with 15, or more, years. Reduced for each year under 25 years service. Disability retirement reduced for each year under 25 years service.
 - c. Tier 3: Retirement after 25 years service and age 55, age 52.5 with 15, or more, years. Reduced for each year under 25 years service. Disability retirement to be determined.
4. Defined Contribution Plans provide a 401(a) account with employer matching contributions. Employer contributions are fully vested after 10 years. Employees choose their investment strategies.
