RESOLUTION NO. 2018-16

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE TOWN OF HUACHUCA CITY, ARIZONA, AUTHORIZING THE TOWN TO ENTER INTO AN INTERGOVERNMENTAL AGREEMENT WITH COCHISE COUNTY FOR PLAN REVIEW AND BUILDING INSPECTION SERVICES.

WHEREAS, occasionally, due to the limited staff which the Town or County has available for this work, the Town or County needs assistance for the administration of the building code to include plan review and building inspections within the Town of Huachuca City and unincorporated areas of Cochise County; and

WHEREAS, the Town and the County have cooperated over the years in providing these backup services, pursuant to an intergovernmental agreement, which is due to expire; and

WHEREAS, the staff of the County has developed a new Intergovernmental Agreement for the provision of these backup services, which is attached hereto as Exhibit AA@ and incorporated herein by this reference; and

WHEREAS, pursuant to A.R.S. sections 9-461, *et seq.*, 11-863 and 11-952, the County and the Town are authorized to enter into agreements such as this for the joint exercise of authority common to the parties and for the performance of services for each; and

WHEREAS, the Mayor and Council have determined that approval of the Intergovernmental Agreement is in the best interest of the Town and its residents.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Town of Huachuca City, Arizona, as follows:

Section 1. The Town is hereby authorized to enter into the Intergovernmental Agreement between Cochise County and the Town of Huachuca City for the provision of plan review and building inspection services, attached hereto as Exhibit AA@ and incorporated herein by this reference.

Section 2. The Mayor of the Town of Huachuca City is hereby authorized and directed to execute said Intergovernmental Agreement on behalf of the Town of Huachuca City.

Section 3. The Town staff is hereby authorized to take all steps necessary and proper to implement said Intergovernmental Agreement and give it effect.

Section 4. All orders or resolutions in conflict herewith are, to the extent of such conflict, hereby repealed, and this resolution shall be in full force and effect immediately upon its adoption.
