<u>Town Hall News</u>—Code Enforcement within the town is going to be more proactive in the coming months. Residents can request print versions of the relevant sections at Town Hall, or you can go to https://www.codepublishing.com/AZ/HuachucaCity. The Town Council along with town staff are in the process of revising and updating the code. All businesses and residents are encouraged to

familiarize themselves with the Town Code, as violations can lead to citations being issued. Here are a few of the most common reports of violation that residents can act upon immediately:

16.15.030 Care of Premises - C. Maintenance of Public Rights-of-Way. It is the duty of all tenants or occupants of any real property abutting any local street or alley in the town or, if no tenant or occupant, then the property owner thereof shall be required, to keep that part of the street between such property lines and the curb, including the gutter of the street on which such property abuts, or up to the median point of an alley, improved or unimproved, in a safe and sanitary condition at all times. Said area shall be kept free from debris, litter, and trash of all kinds, except household waste that is being properly disposed. Grass, weeds, or other groundcover shall not exceed 12 inches. This duty extends to and includes: 1) Any portion of a street or street right-of-way which has been opened for public use between the curb line (or if there is no curb line, the edge of street pavement) and the abutting property line. This includes the abutting sidewalk area (whether the sidewalk is installed or not). Sidewalk areas shall be kept free from sand, leaves, algae growth, vegetation, and slippery conditions. 2) One half of the width of abutting alleys, from the property line to the centerline of the alley.

<u>16.15.020 Litter Control</u> - A. Accumulation of Refuse, Debris and Litter Is Prohibited. Each owner, lessee, tenant, resident, or occupant shall maintain all exterior premises and land, so it is free of accumulated refuse, debris, litter, or inoperable vehicles. This means contained or uncontained refuse, debris or litter that is present on a property in a manner not authorized by the town.

10.15.060 Abandoned Vehicles - Any vehicle remaining parked upon any sidewalk of the town or any disabled vehicle remaining parked upon any street of the town for more than 48-72 hours is declared to be an abandoned vehicle and the police shall forthwith remove the same from the sidewalks or streets of the town at the expense of the owner of such vehicle in accordance with the provisions of Title 28, Chapter 8, Article 5 of the Arizona Revised Statutes (Prior code § 14-3-6).

10.15.020 Blocking Traffic - B. No person may park a motor vehicle or other vehicle within an alley or entrance to a private driveway except for the loading or unloading of materials, and not then unless such loading or unloading can be accomplished without blocking the alley to the free movement of vehicular traffic.

No appointment is needed.



<u>Fry Fire District</u>—During this time of year, it is important to know the signs and symptoms of dehydration and the ways to combat it. Dehydration can occur in any age group and can even be brought on by varying types of illness or medications. Symptoms of dehydration in children are dry mouth and tongue, no tears when crying, no wet diapers for three hours, sunken eyes, cheeks,

restlessness, irritability, and sunken in soft spot on top of the head. Adult symptoms range from extreme thirst, less frequent urination, dark colored urine, fatigue, dizziness, and confusion. The best ways to prevent you or your loved one from becoming dehydrated is to drink plenty of fluids and eat foods with high water content such as fruits and vegetables. If you are feeling sick do not hesitate to call 911. We are always ready and willing to help.



<u>Police Department News-</u> LTC Fell of the Army National Guard presented Chief Jim Thies with a certificate of appreciation that was awarded to the HCPD for their support, collaboration, and participation in Task Force Badge, allowing members of the National Guard to serve with our department while on deployment. Task Force Badge was created in 2021 by

Governor Doug Ducey. In all, about 220 troops have been stationed in four counties helping eighteen sheriff's offices or police departments.



<u>Library News</u>—The Library will be collaborating with the Community Foodbank of Southern Arizona to offer a free afterschool snack program. We are the first location in all of Cochise County to offer this service. Registration forms are available at the library or school. Forms must be returned to the library by September 8th. The program is open to any child of

school age and will start in October.

The Library was awarded a \$4000 grant from the Arizona Library Association and the University of Arizona Center for Rural Health to offer a free Diaper Bank for eight months to children aged 6 and under. Distribution of diapers and wipes will be at the end of the month on a first come first served basis. Caregivers can fill out the monthly registration form at the library. This service is for residents of the 85616 zip code and the children must reside with the recipient. We will open up services to other areas if supplies allow. The library will be resuming our afterschool clubs in September for 4th-8th grades. Coding Club will be on Tuesdays and Electronics Club on Wednesdays, both from 3:45-4:45pm, and will be limited to ten children for each club.
