B. Call to the Public – Mayor

A.R.S. 38-431.01 states the Public Body may make an open call to the public during a public meeting, subject to reasonable time, place and manner restrictions, to allow individuals to address the public body on any issue within the jurisdiction of the Public Body. At the conclusion of an open call to the public, individual members of the Public Body may respond to criticism made by those who have addressed the Public Body, may ask staff to review a matter or may ask that a matter be put on a future agenda. However, members of the Public Body shall not discuss or take legal action on matters raised during an open call to the public unless the matters are properly noticed for discussion and legal action.

C. New Business Before Council - Mayor

Public comment will be taken at the beginning of each agenda item, after the subject has been announced by the Mayor and explained by staff. Any citizen, who wishes, may speak one time for five minutes on each agenda item before or after Council discussion. Questions from Council Members, however, may be directed to staff or a member of the public through the Mayor at any time.

This is for work to be performed by P&M Construction Services Inc at Huachuca City Landfill.

Terms of Contract:

1. P&M Construction will provide an operated 623 Scraper for 40 hours per week
2. P&M Construction will move at least 3,450 cubic yards of material per week
3. Huachuca City Landfill will pay \$6000.00 per week to P&M Construction
4. Huachuca City Landfill will pay \$2400.00 for 1 mobilization in and 1 mobilization out on referenced 623 scraper.
5. Huachuca City Landfill will guarantee at least 40 hours of work per week, weather permitting. If the machine sits more than 20 hours without working, P&M Construction has the option to move machine from the Landfill.
6. Huachuca City Landfill is responsible for daily fuel.
7. P&M Construction is responsible for ground engaging implements such as cutting edges and router bits.
8. Huachuca City Landfill will be responsible for tire repairs caused by debris in Landfill areas.
9. P&M Construction will be responsible for normal tire wear of machine.
